OFFER PRICE

- The Offer Price has been determined at HK\$1.02 per Share, excluding brokerage of 1.00%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%.

NET PROCEEDS FROM THE GLOBAL OFFERING

- Based on the Offer Price of HK\$1.02 per Share, the net proceeds from the Global Offering to be received by the Company, after deduction of the underwriting commissions and other estimated expenses in connection with the Global Offering and assuming no exercise of the Over-allotment Option, is estimated to be approximately HK\$86.17 million. The Company intends to apply such net proceeds in accordance with the purposes set out in the section headed “Future plans and use of proceeds” in the Prospectus.

APPLICATIONS AND INDICATIONS OF INTEREST RECEIVED

- A total of 10,398 valid applications have been received pursuant to the Hong Kong Public Offering on **WHITE** and **YELLOW** Application Forms and through giving **electronic application instructions** to HKSCC via CCASS and through the **HK eIPO White Form** service under the **HK eIPO White Form** for a total of 201,710,000 Hong Kong Offer Shares, representing approximately 16.14 times of the total number of 12,500,000 Hong Kong Offer Shares initially available for subscription under the Hong Kong Public Offering. As the Hong Kong Public Offering is over-subscribed, the reallocation procedure as described in the section headed “Structure of the Global Offering — The Hong Kong Public Offering — Reallocation and Clawback” in the Prospectus has been applied. 25,000,000 Offer Shares have been reallocated to the Hong Kong Public Offering from the International Offering. As a result of such reallocation, the final number of Offer Shares allocated to the Hong Kong Public Offering is 37,500,000 Offer Shares, representing 30% of the total number of Offer Shares initially available under the Global Offering (before the exercise of the Over-allotment Option) and being allocated to 5,807 successful applicants under the Hong Kong Public Offering.
